Volunteers contacted the offices of every obstetrician, gynecologist and midwife in the Treasure Valley. They were asked four questions:

1. Do you perform abortions?
2. Do you perform 'medically necessary' abortion?
3. Who do you recommend or refer to for an abortion?
4. Where do your patients deliver?

The information was then summarized in a letter to each of the physicians discussed in this pamphlet, asking for a written correction if our understanding was incorrect.

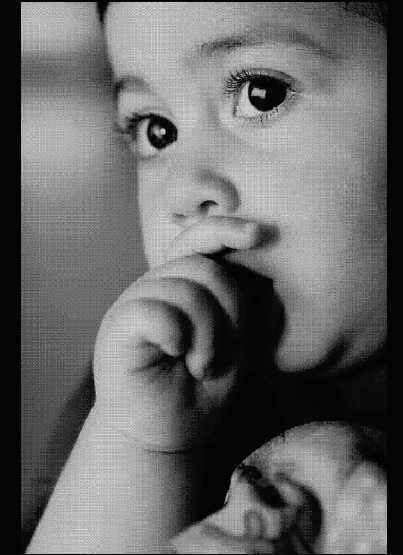
